GRAVES OF REVOLUTIONARY SOLDIERS CLEARED

Myron Kelly, Washington Township Director can sleep better now since a long-time goal he has been trying to reach was finally accomplished on May 9, 1992. Thanks to the help of Debbie McIntyre, Versailles Republican writer. She featured Myron in her "Meet Your Neighbor"

column and his concerns of the historic Old Washington Cemetery near Elrod. The only road to the cemetery was abandoned in 1852 when the log church was burned by an arsonist.

There are possibly 35 graves of members of Old Washington Church and among these are 5 who served in the Revolutionary War. The clearing off was done by Veterans and Boy Scouts. They plan to do this every year - since it had not been cleared for 8 years. Mr. Kelly is a WW II Veteran. An article on the Revolutionary Soldiers who came to Indiana has been published in our previous bulletins, July '87, Oct. '87 and Jan. '88.

MORGAN RAID CLAIMS

Mr. George B. Cowlam, Agent of the Quarter Master's Department, US Army is in town, stopping at the Hassmer Hotel. Mr. Cowlam's business is to investigate such claims as have been filed for property taken by the Union Forces engaged in the pursuit of the Rebel Forces of Gen. Morgan in July 1863, and to report to the authorities at Washington, charged with the settlement of these claims, as to their justness, etc. He will be at Versailles this week, taking up claims in the immediate vicinity and south of this point, and afterward visit points along the railroad, Osgood, Delaware, Milan, notifying claimants whem and where to appear before him to prove their claims. As this investigation is ordered by the government, is free of any expense to claimants and as those who fail to prove their claims when notified will have only themselves to blame for the consequent loss, it will be well for those receiving notices to appear promptly. A STORY FROM HERBERT

Carl Adkins was carrying the mail to Cross Plains. Star Route ran from Versailles to Cross Plains. There was a man in Cross Plains by name of Herbert Miller, son of Dr. Miller. He had the Drug Store and Post Office at Cross Plains and had the first wireless in Ripley County. Carl told Miller that there was a boy at Versailles that had an outfit, too. Miller said, "Bring him down". (As you have guessed, the boy was Herbert Thompson who at this time was 12 or 13 years of age; born in 1907.) "We went down 2 or 3 times." says Herbert. Herbert Miller later moved to Nashville, IN and had a drugstore across from what is now the old Nashville store. Herbert Miller's son works for Hooks Drugs now.

When broadcasting began in 1921, Ray Spencer was interested. Ray repaired phones. Ray had a nice drug store and soda fountain in Ver-He was also a mail carrier. Oscar Hughes, Ray and Herbert Thompson went to Aurora and there went by interurban to Saylor Park and on to Cincinnati by street car to Music Hall to the exposition. Here you could buy parts and assemble your own wireless. to the Electric Co. and Ray bought \$150 worth of parts. Tubes were \$8.00 a piece. Herbert helped him put it together. Ray was shaky and touched 2 wires and burned out 3 tubes. He had to go back to Cincinnati and get 3 new tubes at a cost of \$24. There was one tube one There were 2 pair of head phones so 4 people could on head phones. listen at a time.
