As there was no other business the meeting was turned over to "Bo" Susnick who showed his antique tools. He had a very interesting program. He challenged several people to recognize the different tools he displayed. There was a traveler wheel, bunion stretcher, hitching hammer, fro hammer, pie peal and all different kinds of building tools. He stated he liked hammers of which he has several different kinds. One thing you should never do is to clean up the old tools and make them look like new. Dates and names on the tool will add greatly to its value. I think everyone learned that necessity is the mother of invention. Almost every person had a tool for the job that he was going to do.

Howard Lane's presence will be greatly missed around the museum and annex. He was always on hand to help wherever he could; build it, fix it or solve most any problem we had.

SOCIETY MEMBER SPEAKS AT LOCAL MEETING

The Tuesday evening, September 6, program of the Senior Citizens Mutual Interest Group was a very interesting and informative one given by Mr. Herbert Thompson, of Versailles, on the churches that had been in the area of the now Jefferson Proving Ground.

In December 1940 the news was announced that 55,264 acres, 23,150 in Ripley Co., 22,000 in Jefferson and the balance in Jennings was to be purchased for installation of a military reservation to be used as a testing ground for the \$51,000,000 powder plant built by the U.S. Government and Dupont at Charlestown, IN.

Mr. Thompson showed photographs of each church projected on a

screen and told the fate of the church.

At St. Magdalen Church, 53 of the 60 families were forced to The parish had been started in 1830. The last mass was held in this beautiful church, built in 1861, on February 16, 1941. The purchased 2 acres of land on 421, south of Versailles, across from what is now Silver Bell Nursing Home, but did not build there. Instead they made the Bank Building at New Marion into a church.

Bethel Baptist with a ministry started in 1828 was disbanded. Later they would gather for yearly reunions at North Vernon Park.

Marble Corner Methodist - the last day services were held, a telegram from the White House was read. It was from Eleanor Roosevelt.

Pilgrim Holiness Church founded in 1922 at Marble Corner.

The Liberty Christian Church in Jefferson Co. was the only church not to be destroyed. It was moved from Proving Ground across the then State Road 29, now 421, near Bellview. This is the Oldest Christian Church in the state.

The Otter Creek Baptist in Jennings County, founded in 1848 moved to a school house in Nebraska, IN. Their cemetery was also moved N.W. of Nebraska on Zenas Road.

Mr. Thompson also mentioned the cemeteries moved from Jefferson Proving Ground, referring to the article, "Where Are The J.P.G. Cemeteries Now?" This article appeared in the Ripley County Historical Society Bulletin, April 1982, Vol. VI - # 2.

Herbert Thompson, knowledgeable historian is an active member of the Ripley County Historical Society. He contributes many hours as did his wife Lois until her death in 1984. He was with Verseilles Republican Newspaper for 40 years and also employed at Jefferson Proving Ground.
