Activities at the Archives

- ▶ Don Hughes from the Flat Rock Community brought the first record book of the Flat Rock Church, dated 1843 to 1890's, to the Archives for us to copy. We also copied a record book from the Lock Springs sawmill, dated 1870's to 1890's. The sawmill was owned by Don's gr-grandfather, Hannibal Hughes. This information is valuable to our collection. Thanks so much, Don.
- ▶ This summer we received two large boxes containing the genealogy research of Ray Novak from Sioux Falls, SD. Mr. Novak had years of research work on several families. The main family from Ripley County is the French family that lived near Bear Branch Community. This community is located near the corner where the Ohio, Switzerland, and Ripley Counties meet. This information is in the process of being reviewed and involved families classified. Mr. Novak passed away last year and his wife Margaret sent his information to us. We greatly appreciate receiving information about our Ripley County ancestors. Thank so very much to the Novak family.
- ▶ At our July meeting, Mr. Jack C. Reed from Cincinnati presented the Historical Society with a book he had put together containing a great amount of information and pictures about the Smith-Dickey Cemetery. This small cemetery formally known as the Old Dickey Family Cemetery is located on the Versailles State Park property in Johnson Township. Thanks Mr. Reed for all your work and information, the book has been added to our cemetery records collection.

The following is the conclusion of the accouches from Dr. Jeremiah Roberts of Holton.

There has to be more books. Each of his patients were assigned a number. He kept excellent records even to the credits. Mostly he was paid with cash but also with molasses, spirits, cider, Sleigh bells(cr.\$2.00), Vit Moore received \$1.00 cr. for flour, Hay(%T \$2.00), Sam Parker(1% cord wood \$2.25), Anderson Downey (1 pig,\$1.00,,Cow(cr \$28.50), Smith Downey(\$2.50 cr 10 Bushel oat @25¢),Sarah Boswell(cr. \$6.00 for quilt), Holman Vater(corn \$12.00) Lawrence Miller(115 lb. beef @7c,\$8.05), John Yater(cr,hat),One of the strangest was Jonathon Dickey(cr 3 New shoes). Was he a blacksmith?

In 1882 when the state required that births and deaths be recorded, Dr. Roberts recorded his with the County Health Dept. Dr. Roberts was born in 1839 and died 1918.

We received a grant from Rising Sun Regional Foundation to repair part of the Culver Cemetery in Jackson Township. There were over 66 stones in need of repair and foundations. The RSRF has been very helpful in grants for restoration of Pioneer cemeteries with Revolutionary War Soldiers. The Revolutionary soldier buried in the Culver cemetery is Levi House who enlisted in May 1777 and served in Capt. Hook's Calico Hunting Shirt Company of the Virginia line. At time of enlistment he was living in Washington Co, Virginia (now Pennsylvania). He was a scouteengaged in many rescues of Americans for British Forts.

Red Skelton, a native of Vincennes, Indiana, was a very popular comedian about 40 years ago. On one of his television shows he expressed his love and appreciation for our country. Red related that one of his school teachers, Mr. Laswell, felt that the children did not appreciate the Pledge of Allegiance because they recited it as if it had no meaning to them. So Mr. Laswell explained the meaning of the pledge to his class. Red Skelton later wrote down and eventually recorded, his recollection of this lecture.

I -- me, an individual, a committee of one

PLEDGE -- dedicate all of my worldly goods to give without self-pity

ALLEGIANCE -- my love and my devotion

TO THE FLAG -- our standard, *Old Glory*, a symbol of Freedom, wherever she waves there is respect, because your loyalty has given her a dignity that shouts Freedom is everybody's job

OF THE UNITED -- united means we have all come together
STATES OF AMERICA -- Individual communities that have united into 48 (now 50)
great states with pride and dignity and purpose, all divided with imaginary boundaries, yet
united to a common purpose, which is love for country.

AND TO THE REPUBLIC FOR WHICH IT STANDS – republic, a state in which sovereign power is invested in representatives chosen by the people to govern. And government is the people, and it's from the people to the leaders, not from the leaders to the people.

ONE NATION — one nation, meaning 'so Blessed by God' INDIVISIBLE — incapable of being divided

WITH LIBERTY -- which means freedom, the right of power to live one's own life, without threats, fear, or some sort or retaliation

AND JUSTICE -- the principle or qualities of dealing fairly with others FOR ALL -- which means, boys and girls, it's as much your country as it is mine

"Since I was a small boy, two states have been added to our country and two words have been added to the Pledge of Allegiance: **UNDER GOD** -- Wouldn't it be a pity if someone said that phrase is a prayer and it would be eliminated from schools, too?"
