She was born in Osgood on September 5, 1920 the daughter of Vernon and Alice Knowlton Vavhinger and spent her entire life there. She was married to Norman Caplinger in Bedford, Kentucky on October 19, 1940 and he preceded her in death on April 11, 1994. Survivors include two sons Terry (Cathy Matz) Caplinger of Osgood and Tom (Kathy Braley) Caplinger of Fairland; three grandchildren Mike Caplinger and Bob (Teresa) Caplinger of Thorntown, and Susan (Jason) Luby of Monroe, Georgia. and several great-grandchildren. Historical Society Dedicated Marker at New Marion

Sunday, September 17, 1922

Copied from Versailles Republican & Osgood Journal Sept 20, 1922



The unveiling of the marker erected by the Ripley County Historical Society to mark the site of the first seat of justice in this county drew about a thousand people in New Marion Sunday and was made the occasion of an impressive dedicatory service. The marker is located on the east side of the road at the top of the hill leading up from Big Graham Creek. It is made of Bedford stone and is the gift of Joseph Hassmer. The work was done by Jenkins & Holman. It served as a double purpose, that of marking the site of the first court held in Ripley County, and is also a road marker.

The forenoon program was conducted from a platform near the marker. The Rev. Gains, pastor of the New Marion Baptist congregation delivered the address of welcome and conducted a brief devotional service from the text "where there is no vision the people perish".

Judge F. M. Thompson delivered the address in behalf of the Historical Society. He said that one hundred four years ago last July [July 23,1818] the first circuit court held in this county was convened in the house of Benjamin Brown, which crowned the eminence just east of where the marker stands, by the side of historic Michigan Road.

This was then the third judicial circuit of Indiana and was presided over by Judge Test. Judge Thompson expressed the hope that the marker would serve to remind this and future generations of the hardships and privations endured by our

sturdy forefathers and of their early desire to establish justice and to live under constructed law in place of the mob. He made eloquent plea for renewed devotion to the Constitution of the founders of our State and Nation and for increased respect for obedience to the laws of God and man.

At the close of the exercises at the marker a group photograph was taken. A long table had been prepared on the church lawn and at the noon hour this heaped with mounds of delicious fried chicken, pie, cake and many other edibles prepared and served by the good women of Shelby township who are famed for their culinary skill and hospitality. To this feast all were invited and if any of the multitude departed hungry it was their own fault.



The afternoon exercise was conducted in the Baptist Church which had been artistically decorated for the occasion. This program was lengthy and contained so many good features that only a bare mention can be made of any one of them. Suffice to say that Rev. Rolla Beach and Prof. Arie Taylor came "back home" to talk to their old neighbors and friends who greatly enjoyed their happy reminiscences. The Rev. Scheidler, pastor of the Catholic congregation at St. Magdalene, rend a brief history of that congregation and made a plea for closer relations between Catholics and non-Catholics.

Mrs. Emma King Benham read a poem appropriate to the occasion and which she had composed especially for the event. William E Ryker gave a history of the New Marion Baptist church which was organized in 1835. Mr. Chas. S Royce read a very interesting historical sketch of Shelby Township. Prof. Harry Dannecker read a poem written by his wife, Hazel Donovan Dannecker especially for the occasion.

Letters were read from Judge Charles K Bagot, Rev. Frank Klotscher and Kennie E Rea, former Shelby Township citizens now residing elsewhere, each expressing keen regret at his inability to attend the home-coming and conveying best wished to old friends.

Brief talks were made by Dr. Frank Welch, Dr. Fred Daubtnheyer, Mr. Will P. Castner, Mr. Brainard L. Vawter, Mrs. Lizzie Myers Ellerman, Dr. John N Hess, all of whom expressed their joy at meeting so many old friends and recalling the events of by-gone days.

The music for the day was furnished by local talent under the direction of Mrs. Gertrude Bovard and Mrs. Emma Creath. The biggest event of the day however was the opportunity offered for meeting old friends and renewing old acquaintances.

The historical Society of Ripley County had a big program mapped out. Ripley County is rich in historical material and it is the purpose of the society to collect this material now before those who helped make Ripley County have passed away. History is the record of what had been done by the people whether it is in a nation, state, county or community and it is the history of individual communities that makes the history of the nation.

Everybody should belong to the Historical Society of Ripley County. The dues are only 50¢ per year and the society needs some money to carry on its work. If you cannot participate actively in the work of the society, you can spare 50¢ to help carry on the work. Mrs. Clara Jones of Osgood will accept your money and enroll you as a member of the society.

In conclusion of the very enjoyable and profitable day's events, W.D. Robinson, representing the Ripley County Historical Society, urging the importance of preserving the ancient land-marks and collecting data for a reliable history of Ripley County before descendants of the Pioneers have all passed away.
